From the Chairman of the Board of Trustees


As we conclude our 33rd year we have been reflecting on our growth and future. What began in Kevin Ellison's Chagrin Falls back yard in 1978, serving a handful of students each week, has grown into an enterprise with a 47 thousand square foot facility, 35 horses, 41 full- and part-time staff members including 20 instructors, and more than 600 volunteers, serving nearly 800 students each year.

Fieldstone Farm has grown because of the great need for what our unique program offers. It is likely you know someone who is enrolled in a Fieldstone program, or could be a candidate for enrollment. We serve students of all ages: very young children referred by pediatricians, older adults from assisted living programs, teens in drug treatment programs, accident victims, veterans and school-age children. Our students live with a wide range of physical, emotional and/or cognitive challenges. Some of their disabilities are clear and evident to the eye, and some are invisible to the observer. Each and every session at Fieldstone Farm moves a student toward improvement, and a better quality of life. In many instances, students develop skills, confidence and experience that allows them to more readily participate and contribute to society.



Because Kevin Ellison understood the seismic impact of equine programming on the improvement of students' lives, his goal was to give lessons to all students who needed them, regardless of their ability to pay. What was a goal then, is now one of our guiding principles: a student is never denied services for financial reasons. Therefore, it is the generosity of our individual donors and the foundations that provide funding for programs, the success of our fundraising events, and the thousands of hours devoted by dedicated volunteers that allow Fieldstone Farm to thrive and grow.

We all live in a world that is sometimes overwhelming in its complexity, but here is one very simple truth: when you support Fieldstone Farm, you have a direct and lasting impact on improving the quality of another person's life. Benefits of Therapeutic Riding

The equine programs at Fieldstone Farm are uniquely designed to meet the educational, behavioral, social and physical goals of people with disabilities.

Physical Disabilities:

The horse's unique, three-dimensional movement replicates the movement that the human body experiences while walking. Therefore, sitting on a horse helps to strengthen and stimulate core muscles, which often improves walking ability.

Cognitive Disabilities:

Programming complements the Ohio Academic Content Standards for language arts, math and science. The result is a creative, progressive, experiential learning opportunity, which directly relates to students' state-mandated academic goals.

Psychosocial Disorders:

Horses provide motivation and encouragement to riders. The relationship that develops between client and horse nurtures the development of skills such as responsibility, increased self-esteem, honesty and respect.

Veterans' Services

Fieldstone Farm remains committed to honoring our country's veterans by bringing the benefits of riding, driving and horsemanship to area military service members. For veterans recovering from war-related injury, equine-assisted activities can provide physical, emotional and rehabilitative support, helping with the transition back to civilian and family life.

This program is proudly supported by the Ohio Professional Horsemen's Association.

Volunteer Commitment

Fieldstone Farm volunteers demonstrate extraordinary commitment every day: to our students, our beloved therapy horses, the Gaitway school and to each other. Through selfless dedication and hard work, our volunteers contribute the workforce that runs our classes and improves our facility. In 2011, 650 volunteers donated 22,190 hours to our program by assisting our students, helping on committees, volunteering for special events and of course, working with our horses. The Independent Sector's current value of one hour of volunteer service is \$21.36, making our volunteers' efforts worth \$473,978 to the organization.

Therapy Horse Spotlight

Have you ever wondered what goes into becoming a Fieldstone Farm therapy horse? It's not as easy as you might think. In 2011, 109 phone calls were received from potential horse donors. Of that number, 26 horses were screened at their home barns. From those visits, 13 horses were brought to Fieldstone for the trial horse phase, a 6–8 week time period when staff and EMTs (Equine Management Team, a group of volunteers who meet weekly to help with various training aspects of the herd) work with the horse to ensure compatibility with our program and student population. From this group, seven horses were accepted into the program. And you thought your job interview was tough! At year-end, Fieldstone Farm owned 36 carefully selected horses.

Programs at Fieldstone Farm

- **Academic Enrichment**—math, science, language arts and social skills focus that complement state-mandated curricula
- **Carriage Driving**—horse drawn carriage
- **Competition Opportunities**—two horse shows per year
- **EquiClub**—a “4-H club-styled” horsemanship program
- **Equine Partnerships**— non-riding program supported by a social worker
- **Gaitway High School**—for students needing a unique educational environment combined with mental health and social skills support
- **Hippotherapy**—physical or occupational therapy on horseback
- **Instructor Training Program**— education and skill trainings to become a certified therapeutic riding instructor
- **Memory Lane** – a program to engage seniors with memory deficit
- **Specialty Programming**—programming specifically refined to meet the needs of those touched by cancer, students on the autism spectrum and our veterans of the armed forces
- **Summer Day Camp**—an equine adventure


