# Gaitway high school

## PROJECT BASED LEARNING

If you are new to the Gaitway High School experience, you may have pondered our logo: a stylized horse with the name of the school and the motto, "Learning Outside the Box." One distinctive aspect of our educational philosophy is an instructional approach known as project-based learning. In this approach, students not only meet academic content standards, they also gain a number of 21st-century employability skills: communication and presentation skills, the ability to work collaboratively, organization and time management, and research and inquiry skills. A well-designed project causes students to encounter and struggle with real-life problems, which leads to in-depth learning.

Whether in job skills, vocational training or academic disciplines, Gaitway students are encouraged to "learn outside the box" to gain essential knowledge. Through this approach, students acquire creativity, flexible thinking, and active listening skills. Project-based learning also enhances social skills. One student's English project led to the formation of a Student Council which will be starting soon. Our Pond Study project led to cooperative learning in life science. A project will soon be underway that involves debate, science, history, and the judicial process as students work together to produce a mock trial.

Evidence supports the effectiveness of project-based learning. That is why it is an important aspect of the Gaitway experience.


